

# ARTICLES OF ORGANIZATION OF JONATHAN D. PERRY CONSTRUCTION, LLC, a Florida limited liability company



#### ARTICLE I

#### NAME

The name of this limited liability company is JONATHAN D. PERRY CONSTRUCTION, LLC.

#### **ARTICLE II**

#### **PURPOSE**
