

A check is enclosed for \$55 to cover the fee and expense for a certificate.

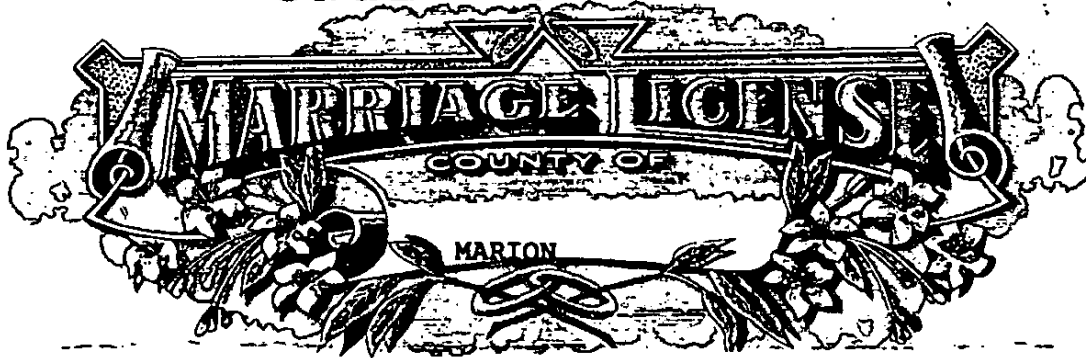
