## ARTICLES OF ORGANIZATION OF AMAZON COURT, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapte 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be Amazon Court, L.L.C. ("Company").

#### ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 6436 Glenway Avenue, Cincinnati, OH 45211.

#### ARTICLE III -- DURATION

#### ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members.

#### ARTICLE VII -- ADMISSION OF NEW MEMBERS

These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
