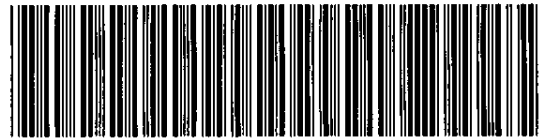

**FIRST AMENDMENT TO ARTICLES OF ORGANIZATION

Pursuant to the terms of the Articles of Organization of 1700 Building, LLC, a Florida limited liability company, dated January 7, 2004, the undersigned, being all of the Managing Members of 1700 Building, LLC (the "Company"), do hereby certify that the following is the First Amendment to the Articles of Organization of 1700 Building, LLC.

Section 1: Recitals

The Managing Members of the Company filed the Articles of Organization of the Company on January 7, 2004 ("Articles of Organization").

The Purpose of this First Amendment to the Articles of Organization is to reflect the transfer by George W. Weaver as Managing Member of 33.48% of his 47.785% interest as a Member in 1700 Building, LLC, to Jefferson H. Weaver, Trustee, as Managing Member in 1700 Building, LLC, under the Articles of Organization. Following this transfer, GEORGE W. WEAVER's interest in 1700 Building, LLC, will decline from 47.785% to 31.78% and the interest of JEFFERSON H. WEAVER, Trustee, in 1700 Building, LLC, will increase from 47.785% to 63.79%.

Section 2: Modification

Amendment. The Articles of Organization of 1700 Building, LLC, is hereby amended by deleting the first sentence of Article VI Capital Contributions from the Articles of Organization and substituting in its place the following sentence:

"Capital contributions, if any, shall be paid to the limited liability company by the three members in such shares as to create the following ownership interests: George W. Weaver 31.78%, Jefferson H. Weaver, Trustee 63.79%, William F. Koch, Jr., 4.43%."

Except for the amendment stated above in Section 2 regarding the change in ownership interests, the terms and conditions of the Articles of Organization as amended remain in full force and effect.

In Witness Whereof, the Managing Members have executed this First Amendment to the Articles of Organization of 1700 Building, LLC, effective this 28 day of February, 2015.

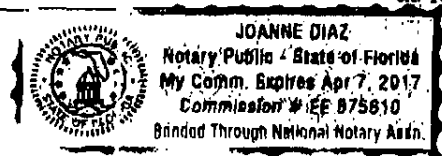
