THIRD AMENDMENT to ARTICLES OF ORGANIZATION OF 1700 BUILDING, LLC

Pursuant to the terms of the Articles of Organization of 1700 Building, LLC, a Florida limited liability company, dated January 7, 2004, as amended March 4, 2015, and as further amended January 12, 2016, the undersigned, being all of the Managing Members of 1700 Building, LLC (the "Company"), do hereby certify that the following is the Third Amendment to the Articles of Organization of 1700 Building, LLC.

Section 1. Recitals

The Managing Members of the Company filed the Articles of Organization of the Company on January 7, 2004 ("Articles of Organization"). The First Amendment to the Articles of Organization was filed on March 4, 2015 ("First Amendment") whereby George W. Weaver as Managing Member transferred 33.48% of his 47.785% Interest as a Member in 1700 Building, LLC, to Jefferson H. Weaver, Trustee, under the Articles of Organization. The Second Amendment to the Articles of Organization was filed on January 12, 2016 ("Second Amendment") whereby George W. Weaver as Managing Member transferred his remaining 31.78% Interest as a Member in 1700 Building, LLC3, to Jefferson H. Weaver, Trustee, as Managing Member in 1700 Building, LLC3, under the Articles of Organization as Amended.

The Purpose of this Third Amendment to the Articles of Organization as amended is to reflect the transfer by William F. Koch, III and Claudia K. Burns, Personal Representatives of the Estate of William F. Koch, Jr. (File No. 502012CPO 0 3022 XXXX MB in the Probate Division of the Circuit Court for Palm Beach County, Florida) of William F. Koch, Jr.'s entire 4.43% Interest as a Member in 1700 Building, LLC, to Jefferson H. Weaver, Trustee, as Managing Member in 1700 Building, LLC, under the Articles of Organization as amended. Following this Transfer, the Estate of William F. Koch, Jr.'s interest in 1700 Building, LLC, will decline from 4.43% to 0.00% and the interest of Jefferson H. Weaver, Trustee, in 1700 Building, LLC, will increase from 95.57% to 100.00%.

Section 2: Modification

Amendment. The Articles of Organization of 1700 Building, LLC, as amended, are hereby further amended by deleting the first sentence of Article VI Capital Contributions from the Articles of Organization and substituting in its place the following sentence:

"Capital contributions, if any, shall be paid to the limited liability company by the members in such shares as to create the following ownership interests: Jefferson H. Weaver, Trustee 100.00%"

Except for the amendment stated above in Section 2 regarding the change in ownership interests, the terms and conditions of the Articles of Organization as amended remain in full force and effect.
