

- FIRST:** The name and address of this ^{company} ~~corporation~~ is **ARG PROPERTIES, L.L.C.**, 168 S.E. 1st Street, Suite 600, Miami, Florida 33131.
- SECOND:** The date of the adoption of these Articles of Dissolution is 15 August 2006.
- THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
