ARTICLES OF ORGANIZATION OF BUCKSTONE PROPERTY, LLC

The undersigned certifies that she is executing and filing these Articles for the purpose of forming a Limited Liability Company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. She further declares that the following Articles shall serve as the Charter and authority for the conduct of the business of the Limited Liability Company.
