Other Provisions

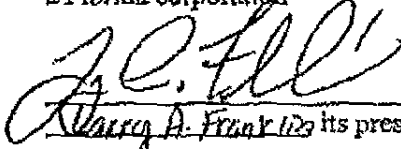

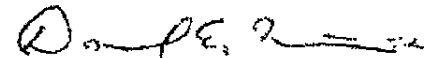
