AMENDMENT TO ARTICLES OF ORGANIZATION


The undersigned sole owner of American Dream Realty Group, LLC, a Florida limited liability company, hereby amends the articles of organization as follows:

a. The managing manager of this limited liability company is Richard J. Fairchild, licensed real estate broker.


