### ARTICLES OF ORGANIZATION MASTERSTYLIST, LLC

The undersigned, acting as organizer, for the purpose of forming a limited liability company under Chapter 608, Florida Statutes, Limited Liability Companies, hereby acknowledges and adopts these Articles of Organization:

#### ARTICLE I - NAME

The name of this limited liability company is: MASTERSTYLIST, LLC.

#### ARTICLE II - PRINCIPAL OFFICE

The mailing address is: 5540 VIA DE LA PLATA CIRCLE, Delray Beach, Florida 33484 and principal office of this limited liability company is: 123 S. Swinton Avenue, Delray Beach, Florida 33444. The limited liability company may have such other place of business, both within and without the State of Florida, and in foreign countries, as may be necessary or convenient.

#### ARTICLE III - REGISTERED AGENT

#### ARTICLE IV - MANAGEMENT

- (4) purchase, receive, subscribe for, or otherwise acquire, own, hold, vote, use, sell, mortgage, lend, grant a security interest in, or otherwise dispose of and deal in and with, shares or other interests in or obligations of any other entity;
- (5) make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the limited liability company; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly or indirectly, a majority of the outstanding membership interests of the contracting limited liability company; or a corporation the majority of the outstanding

stock of which is owned, directly or indirectly, by a corporation which owns, directly or indirectly, the majority of the outstanding membership interests of the contracting limited liability company, which contracts of guaranty and suretyship shall be deemed to be necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company; or make other contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of the contracting limited liability company;

- (6) lend money, invest or reinvest its funds, and receive and hold real or personal property as security for repayment;
- (7) conduct its business, locate offices, and exercise the powers granted by this chapters within or without this state;
- (8) select managers and appoint officers, directors, employees, and agents of the limited liability company, define their duties, fix their compensation, and lend their money and credit;
- (9) make donations for the public welfare or for charitable, scientific, or educational purposes;
- (10) pay pensions and establish pension plans, pension trusts, profit-sharing plans, bonus plans, option plans, and benefit or incentive plans for any or all of its current or former managers, members, officers, agents, and employees;
- (11) be a promoter, incorporator, shareholder, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other entity;
- (12) make payments or donations or do any other act not inconsistent with law that furthers the business of the limited liability company;
