**ARTICLES OF ORGANIZATION  
FOR  
SUNBELT CUSTOM HOMES, L.L.C.**

Pursuant to the Provisions of Chapter 608 of the Florida Statutes, 2003, the undersigned hereby adopts the following Limited Liability Company Articles of Organization.

**ARTICLE I**

**Name and Address**

- (2) The date upon which a dissolution occurs pursuant to the terms of the Operating Agreement of the Company, as in effect on the date a dissolution occurs.

### ARTICLE III

#### Purposes

The company is formed for the purposes of acquisition, ownership, operation, management, mortgaging, encumbering, selling, exchanging, leasing, developing, constructing, or otherwise disposing of property (including real or personal property, tangible or intangible), participating in venture capital financing to the extent and in the manner permitted by applicable law, acquiring and holding various stocks, securities, bonds and other investment and property ownership interests, and the transaction of other lawful acts or activities for which limited liability companies may be organized pursuant to the Florida Limited Liability Company Statute. The Company is not to engage in any act or activity requiring any consents or approvals by law without such consent or approval being first obtained. In addition to the powers prescribed by law, the Company shall have the power to do all things necessary or convenient to accomplish its purpose and operate its business and affairs, all in accordance with applicable law.

### ARTICLE IV

#### Registered Office; Registered Agent

The location and street address of the initial registered office of the Company shall be 4601 Baybrook Drive, Pensacola, Florida, 32514, and its registered agent at such address shall be Carlton D. Bowers.

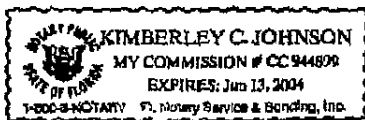

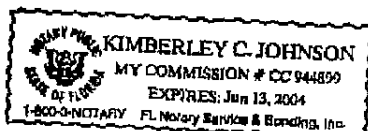
