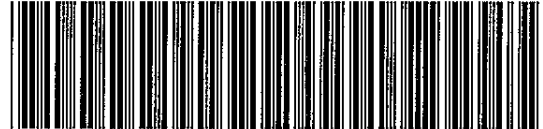

ARTICLE XI: AMENDMENT


