

ARTICLES OF ORGANIZATION

MOUHOURTIS CONSTRUCTORS, LLC,

A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - NAME

The name of the Limited Liability Company is: MOUHOURTIS CONSTRUCTORS, LLC.
