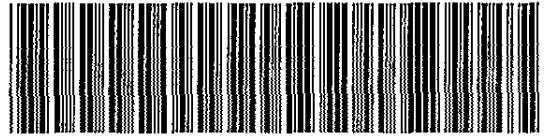

ARTICLES OF ORGANIZATION
OF

THE UNDERSIGNED, CHAIM J. MARGOLIN, Trustee Of the Chaim J. Margolin Revocable Trust dated 10-20-97 and FRANCINE N. MARGOLIN, Trustee of the Francine N. Margolin Revocable Trust dated 10-20-97; FRANCINE N. MARGOLIN, Trustee of the Nathan G. Margolin Irrevocable Trust dated 12-31-03 and FRANCINE N. MARGOLIN, Trustee of the Max A. Margolin Irrevocable Trust dated 12-31-03 for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME AND PRINCIPAL OFFICE

ARTICLE VI - MANAGEMENT



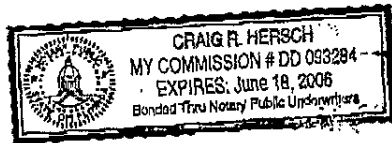
