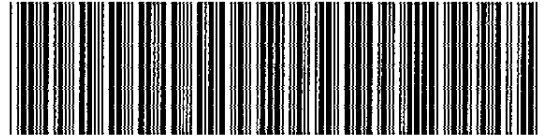

- SECOND:** The date of filing of the Articles of Organization was January 8, 2004.
- THIRD:** The Company subsequently filed an Article of Amendment to Articles of Organization on May 23, 2005 amending Article I of the Articles of Organization changing the name of the Company to BRADLEY MACKIN THREE, LLC.
