# ARTICLES OF ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY 04 JAN -5 AM 10: 35

The undersigned authorized representative, desiring to form a Thinted Hability company
pursuant to the provisions of the Florida Limited Liability Company Act, hereby submits, and files

#### ARTICLE I - Name
