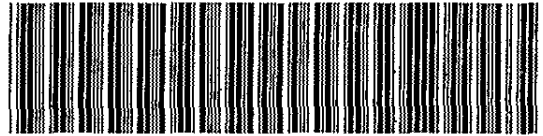

**ARTICLES OF ORGANIZATION
OF

Pursuant to Section 608.407 of the Florida Statute**

First: The name of the limited liability company is: **VERIX TRADE LTD. CO.**
