





PLAN OF MERGER

This Plan of Merger is made effective as of the date that a Certificate of Merger is filed with the Department of State of Florida, between Duck Pond Enterprises, LLC, a Florida limited liability company, referred to as the Surviving LLC, and FAL, LLC, a Florida limited liability company, referred to as the Absorbed LLC.

Stipulations

- A. The Surviving LLC is a Florida limited liability company and existing under the laws of the State of Florida, with its principal office at 6440 West Newberry Road, Suite 508, Gainesville, Alachua County, Florida, 32605.
- B. The Absorbed LLC is a Florida limited liability company and existing under the laws of the State of Florida, with its principal office at 6440 West Newberry Road, Suite 502, Gainesville, Alachua County, Florida, 32605.
- C. The Managers and Members of the Absorbed LLC deem it desirable and in the best business interest of the Members that the Absorbed LLC be merged into the Surviving LLC pursuant to the provisions of Chapter 608 of the Florida Statutes.

In consideration of the mutual covenants, and subject to the terms and conditions set forth below, the constituent limited liability companies agree as follows:

1. <u>Merger</u>. Effective upon the filing of a Certificate of Merger with the Department of State of Florida, the Absorbed LLC shall merge with and into Duck Pond Enterprises,

LLC, which shall be the Surviving LLC.

- 2. Terms and Conditions. On the effective date of the merger, the separate existence of the Absorbed LLC shall cease, and the Surviving LLC shall succeed to all the rights, privileges, immunities, and franchises, and all the property real, personal, and mixed of the Absorbed LLC, without the necessity for any separate transfer. The Surviving LLC shall then be responsible and liable for all liabilities and obligations of the Absorbed LLC, and neither the rights of creditors nor any liens on the property of the Absorbed LLC shall be impaired by the merger.
- 3. <u>Conversion of Interest</u>. Each Member's interest in the Absorbed LLC on the effective date of the merger shall be converted into a proportionate membership interest in the Surviving LLC so that all resulting Members of the Surviving LLC shall have an equal ownership interest in the Surviving LLC and shall have their respective capital accounts in the Surviving LLC adjusted to reflect their capital accounts in each of the limited liability companies that existed prior to the merger.
- 4. Operating Agreement. The Operating Agreement of the Surviving LLC shall continue to be its controlling document following the effective date of the merger.
- 5. <u>Management</u>. The management of the Surviving LLC as of the effective date of the merger shall be comprised of the following Managing Members:

Neither entity shall, prior to the effective date of the merger, engage in any activity or transaction other than in the ordinary course of business, except that the Absorbed LLC and Surviving LLC may take all actions necessary or appropriate under the laws of the State of Florida to consummate this merger.
- 7. Approval by Members and Managers. This Plan of Merger was submitted for the approval of the Members and Managers of the Absorbed LLC and the Members and Managers of the Surviving LLC in the manner provided by Chapter 608, Florida Statutes, and was unanimously adopted. Each limited liability company to this merger has complied with the terms of its respective Articles of Organization and its respective Operating Agreement.
- 8. <u>Effective Date of Merger</u>. The effective date of this merger shall be the date upon which the Certificate of Merger is filed with the Department of State of Florida.
- 9. <u>Execution of Agreement</u>. This Plan of Merger may be executed in any number of counterparts, and each counterpart shall constitute an original instrument.






