#### ARTICLE VI - VOTING RIGHTS/RIGHT TO RECEIVE PROFITS

The Company has two (2) classes of membership containing the following restrictions or rights:

Class A: Full voting rights on all matters.

Class B: No voting rights.

The Company may divide profits by class in a manner it deems appropriate and which may not be representative of a percentage of membership interest in the Company. At formation, the classes of membership shall be entitled to the following right to receive profits:

Class A: 50% of all profits (to be divided equally among such members)

Class B: 50% of all profits (to be divided equally among such members)

Such division is subject to change by a majority vote of the voting members.

#### ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS

The remaining members of the Company can continue the business on the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member upon the terms and conditions as provided in the Company Regulations, upon approval.
