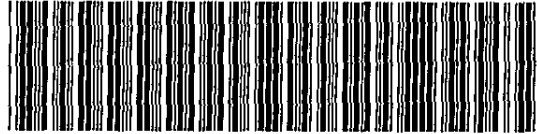

1. The following amendment(s) to the Articles of Organization was/were adopted by the Limited Liability Company:


Article I of the Articles of Organization shall be deleted in its entirety and replaced as follows:
