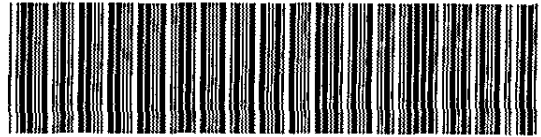

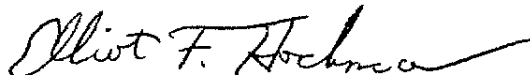

**ARTICLES OF ORGANIZATION**  
**OF**

**A LIMITED LIABILITY COMPANY**  
(Pursuant to s. 608.407, Florida Statutes)

1. **Name.** The name of the limited liability company is **MEDIA MANAGEMENT TECHNOLOGIES, LLC.**
2. **Purpose.** The purpose of this limited liability company may include the transaction of any and all lawful business for which limited liability companies may be organized in the state of Florida.

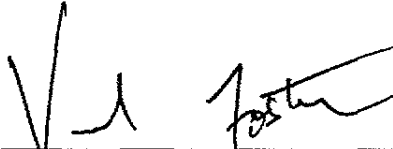
