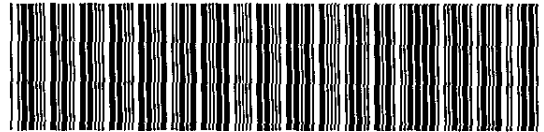

**ARTICLE I**

**NAME**

The name of the Limited Liability Company is FIRST CAPITAL DIRECT, LLC (the "LLC").

**ARTICLE II**

**MAILING AND STREET ADDRESS**

The mailing and street address of the principal office of the LLC is 1000 N.W. 65<sup>th</sup> Street, Suite 200, Fort Lauderdale, Florida 33309.

**ARTICLE III**

**REGISTERED AGENT AND OFFICE**

**ARTICLE IV**

**MANAGEMENT**

Pursuant to Section 608.4227 Liability of members, managing members, and managers.-- Except as provided in this chapter, the members, managers, and managing members of a limited liability company are not liable, solely by reason of being a member or serving as a manager or managing member, under a judgment, decree, or order of a court, or in any other manner, for a debt, obligation, or liability of the limited liability company
