ARTICLES OF ORGANIZATION
OF
FAMILY MATTERS, L.L.C.

THE UNDERSIGNED, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida does set forth the following:

ARTICLE I - NAME

The name of the Limited Liability Company is : Family Matters, L.L.C.

ARTICLE II - PERIOD OF DURATION

The period of duration of the Limited Liability Company shall be perpetual.

ARTICLE III - PURPOSE

The purpose for which the Limited Liability Company is organized to engage in the transaction of any or all lawful business for which limited liability companies may be incorporated under the provisions of the Florida Limited Liability Company Act. CONTINUITY OF BUSINESS
