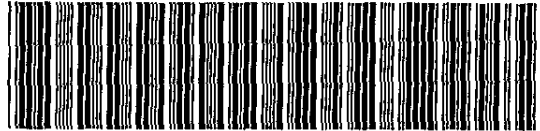

**ARTICLES OF ORGANIZATION OF
QUEENSLAKE INVESTMENT, L.L.C.**

**ARTICLE I
NAME**

The name of this Limited Liability Company shall be: **QUEENSLAKE INVESTMENT, L.L.C.**

**ARTICLE II
PURPOSE**


