ARTICLES OF ORGANIZATION OF QUEENSLAKE INVESTMENT, L.L.C.

ARTICLE I NAME

The name of this Limited Liability Company shall be: QUEENSLAKE INVESTMENT, L.L.C.

ARTICLE II PURPOSE
