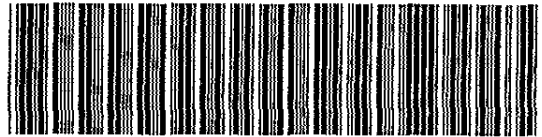

ARTICLES OF ORGANIZATION


ARTICLE VII

New members may be admitted to the Company with the consent of all members as provided in the Operating Agreement.


