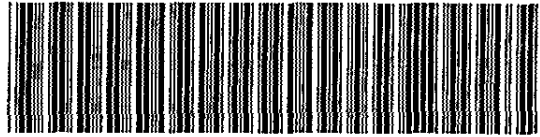

The undersigned person, having the age of eighteen (18) years or more, has associated herself for the purpose of forming a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Organization.

1. **Name.** The name of this limited liability company is Firstklasstennis, LLC
2. **Purpose and Powers.** This corporation is organized for the transaction of any and all lawful business for which limited liability companies may be incorporated under the laws of the State of Florida, as they may be amended from time to time.
3. **Duration.** The duration of this corporation shall be for in perpetuity.
4. **Statutory/Registered Agent.** The corporation appoints Steve Smith who is a bona fide resident of Florida. This appointment may be revoked at any time in accordance with the rules of the State of Florida.
5. **Registered Place of Business.** The initial registered place of business shall be:

6. **Management.** The Company is to be a manager-managed Company

7. **Voting and Non-Voting members.** There shall be voting and non-voting membership interest in the Company. Only the Manager shall own any voting interest in the Company. The rights of the members owning voting and non-voting interests shall be set forth in an Operating Agreement.
8. **Admission of New Members.** Members of the Company have the right to admit new members upon the written consent of a majority interest of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time new members are admitted.
