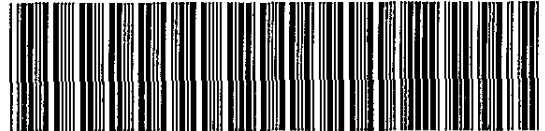

ARTICLE 1 - NAME

The name of the limited liability company shall be **MFA VENTURES, LLC**, ("Company").

ARTICLE 2 - ADDRESS

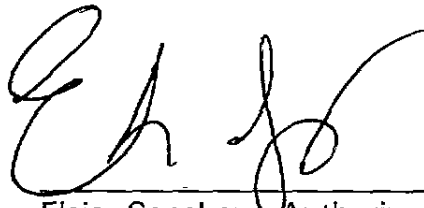
