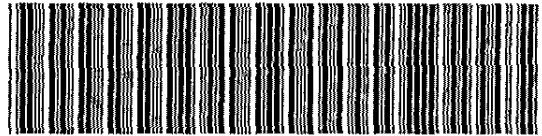

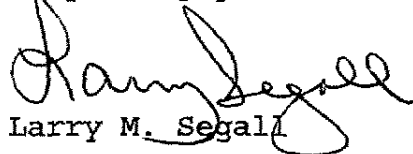

ARTICLES OF DISSOLUTION OF
