



ARTICLES OF ORGANIZATION

of

SOUTHERN PROPERTY PARTNERS, LLC



ARTICLE I. NAME

The name of the Limited Liability Company ("Company") shall be Southern Property

Partners, LLC.

ARTICLE II. PRINCIPAL PLACE OF BUSINESS
