

ARTICLES OF ORGANIZATION

OF

TG TILE & MARBLE, LLC



The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be TG TILE & MARBLE, LLC, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 426 Mickleton Loop, Ocoee, Florida 34761 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective as of the 14th day of January, 2004.

ARTICLE 4 - DURATION
