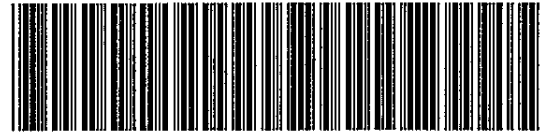

NAME

The name of the company shall be ROBERT C. HARTMANN ROOFING, L.L.C.

ARTICLE II

ADDRESS OF PRINCIPAL OFFICE

ARTICLE III

PURPOSE


