

ARTICLES OF ORGANIZATION DEFERRED INVESTMENTS, LLC

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 et seq., Florida Limited Liability Company Act, as amended, hereby sets forth the following:

The name of the Limited Liability Company is DEFERRED Article I. Name. INVESTMENTS, LLC
