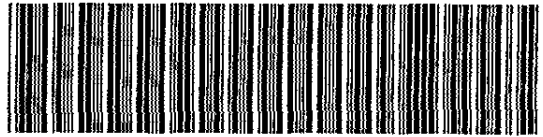


ARTICLE VII




