Pursuant to the provisions of Chapter 608 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of C&JW, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is C&JW, LLC, and its principal office and mailing address is 184 3rd Street West, Tierre Verde, Florida 33715.

ARTICLE 2: DURATION
