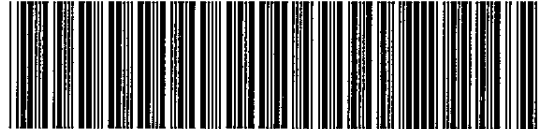

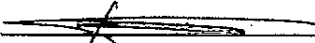
#### **ARTICLE V – Admission of Additional Members:**
