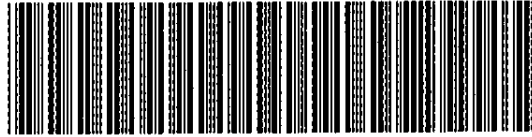

### ORDER AUTHORIZING GUARDIAN TO ACT

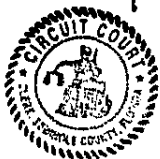


ADJUDGED as follows:
