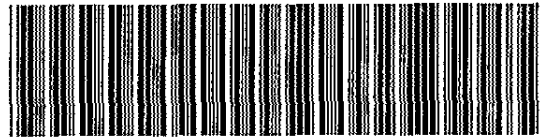

Continuation of Business

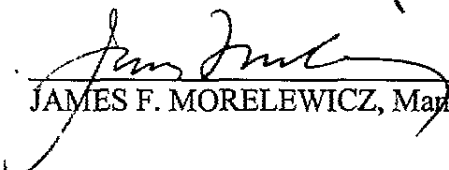

Admission of Additional Members

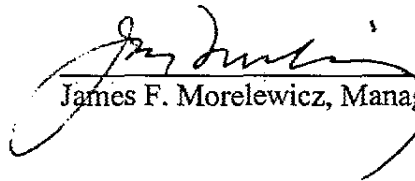

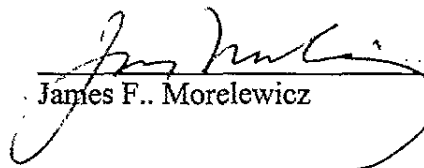
