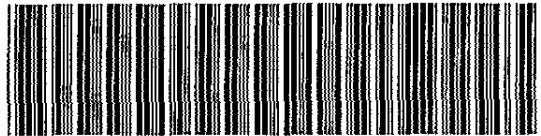

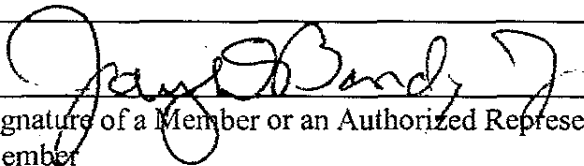

### CONTINUATION OF BUSINESS

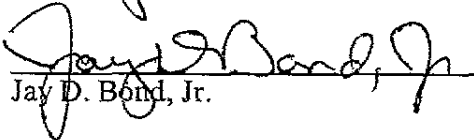

### ADMISSION OF ADDITIONAL MEMBERS

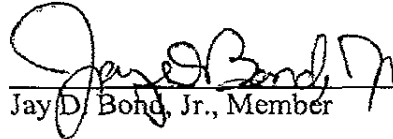

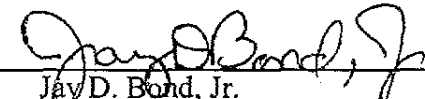
