ARTICLES OF ORGANIZATION
OF
SOUTHWEST FLORIDA BUILDING INSPECTIONS, L.L.C.

The undersigned person, acting as the organizer of SOUTHWEST FLORIDA BUILDING INSPECTIONS, L.L.C., under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, adopts the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is:

SOUTHWEST FLORIDA BUILDING INSPECTIONS, L.L.C.

ARTICLE II - COMMENCEMENT AND DURATION OF EXISTENCE

The existence of the company will commence on January 15, 2004, and shall continue for a term of three (3) years from the date hereof at which time the Company shall be dissolved unless all of the then Members of the Company elect to continue the Company's existence.

ARTICLE III - PURPOSE

The company may transact any or all lawful business for which a limited liability company may be organized under the Florida Limited Liability Company Act.


ARTICLE XI - AMENDMENT OF ARTICLES OF ORGANIZATION
