ARTICLES OF ORGANIZATION

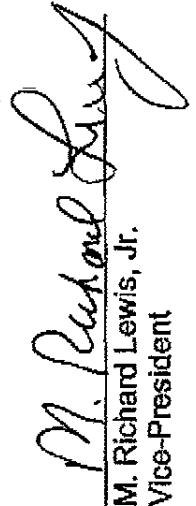
