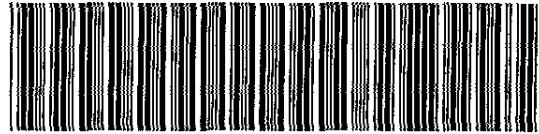



Article III — Registered Agent, Registered Office


