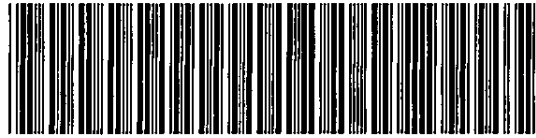


Please find enclosed two separate requests to dissolve two limited liability companies along with the applicable \$25 fee for both requests.


