A FLORIDA LIMITED LIABILITY COMPANY**

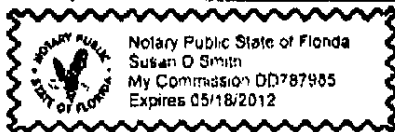
- FIRST:** The name of the limited liability company is Windward Passage Developers, LLC (the "Company").
