ARTICLES OF ORGANIZATION

OF

EMPOWER SEARCH.COM, LLC

a Florida Limited Liability Company

ARTICLE I NAME

The name of this Limited Liability Company is EMPOWER SEARCH.COM, LLC (the "Company").

ARTICLE II PURPOSE



ARTICLE V MANAGEMENT

ARTICLE VII ADMISSION OF NEW MEMBERS

The members shall not have the right to admit new members to the Company. The Members may from time to time, without amending these Articles, move the registered office to any other address within the State of Florida.
