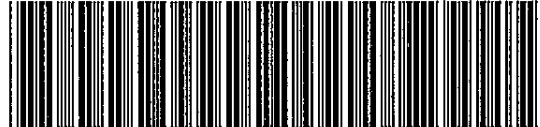

ARTICLE VI – Admission of Additional Members


The members will have the right to admit additional members.
