

ARTICLE III



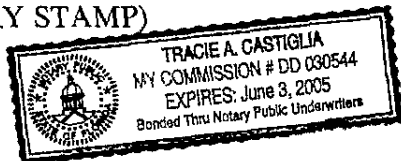
