(the "Company").

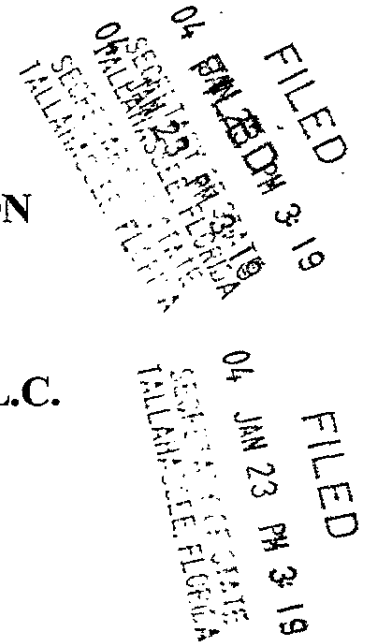
ARTICLE II


