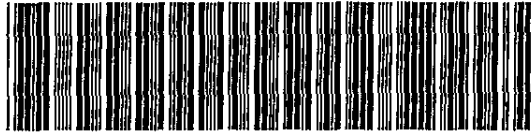

ARTICLES OF ORGANIZATION OF ELCO ENTERPRISES, LLC

Article I

The name of the limited liability company ("Company") is ELCO ENTERPRISES, LLC

nature of contributions by new members at the time the new members are admitted.


Article VII
