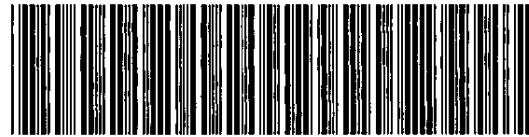

6. There are no lawsuits pending against the company in any court.

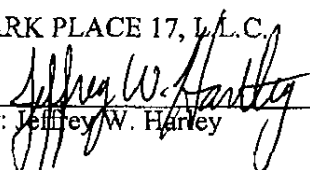
